COMMUNICATIONS:

Letter was received from New York State Agriculture and Markets, Kathleen Wright, Animal Health Inspector, with the Municipal Shelter Inspection Report of the Chenango County SPCA facilities, Norwich, NY. The SPCA received Satisfactory rating 365.

The SPCA Contract for the year 2017 was received. Following discussion, a motion was made by John Hofmann and seconded by Jerry Locke to accept the SPCA Contract for 2017. Motion carried by 5 Ayes.

Letter was received from Stokes & Levy, Attorneys and Counselors at Law, Cazenovia, NY, for consideration of their proposal for the provision of professional legal services to the Town of Oxford. The Town Board was in agreement that the Town of Oxford retain Stokes & Levy as an independent legal contractor on an as needed basis at \$85.00 per hour (paralegal time) and \$160.00 (Attorney time).

HIGHWAY SUPERINTENDENT'S REPORT:

Highway Superintendent Tefft report that the following items have been completed that were recommended by the New York Municipal Insurance on their recent inspection of the Town Highway Garage: (1) the electrical outlets in the break room has been replaced with ground fault circuit interrupters (GFCI). (2) master battery disconnect switches have been added to the plow/dump trucks (3) a sign has been installed near the diesel fuel pumps to instruct drivers to shut engine off while fueling.

There was a clutch problem on one of the trucks and is now fixed. Mr. Tefft stated that if the new loader was ordered now, it could be delivered by February.

Motion was made by John Hofmann to purchase a new John Deere 624K Loader from Five Star Equipment, Kirkwood, NY, using Quote ID #13073538 in the amount of \$149,358.74 with a trade-in of the old 2005 John Deere 624J for \$42,000 which brings the balance due to \$107,358.74. Motion was seconded by Carl Koenig and carried with 5 Ayes.
